Due to the nature of the fabric, FabFlow™ and long directional throw models using nozzles or jets are not an option. The fabric is machine washable and retains its dimensions after washing (max. 0.5% shrinkage). Shape retention options are available. It comes with a 3-year warranty and is supplied in 4 standard colors.
